Membership Application Procedure

- 1. Interested applicant is required to complete our prescribed membership application form for submission to our Association's office together with the required documents and membership entrance and subscription fees for processing.
- 2. The Association's Secretariat, upon receiving the membership's application, would review and verify the following:
 - (1) The applicant shall meet the required terms and conditions for membership application;
 - (2) Submitted all required documents;
 - (3) Submitted all required membership entrance and subscription fees;
 - (4) Brief introduction of the applicant's company.
- 3. If the submitted information is insufficient, the applicant shall be requested to provide additional.
- 4. Our Association's members would be asked to express their opinion on the applicant.
- 5. Upon approval of membership application by the Board of Management, the applicant would be notified in writing.

Article 4 MEMBERSHIP

4. Categories of members

The Association shall have two categories of membership for the time being as follows:

- 4.1. Ordinary Membership and
- 4.2. Associate Membership

Article 5 ADMISSION CRITERIA

5.1. Ordinary Membership

Any applicant applying to be an Ordinary Member shall be required to meet all the following requirements at the time of application:

- (a) any corporation, company, firm, agent or any other form of business entity duly incorporated or registered under the relevant law of Singapore with its main business activities related to the rubber trade and industry; and
- (b) undertake to abide by the Constitution and/or resolutions of the Association.

5.2. Associate Membership

Any applicant applying to be an Associate Member shall be required to meet all the following requirements at the time of application:

- (a) any corporation, company, firm, agent or any other form of business entity duly incorporated or registered under the relevant law of Singapore or other countries; and
- (b) undertake to abide by the Constitution and/or resolutions of the Association.

Article 8 AUTHORISED REPRESENTATIVE

- 8.1. Any applicant applying to be an Ordinary or Associate Member shall at the time of application nominate an Authorised Representative who shall comply with all the following requirements:
 - (a) be at least 21 years of age;
 - (b) be of sound mind;
 - (c) be a director or officer of the applicant or such other person as the Board may approve;
 - (d) not being a person convicted of a criminal offence in any country and sentenced to pay a fine exceeding S\$2,000 (or its equivalent) or imprisonment exceeding two weeks; and
 - (e) must not be an undischarged bankrupt.

- 8.2. Should any Authorised Representative fail to meet the requirements stipulated in Article 8.1. above, it is the duty of the member concerned to notify the Association within 30 days of such occurrence and nominate a replacement who shall meet all requirements of Article 8.1.
- 8.3. Should any member wish to nominate an Alternate Authorised Representative, it shall do so by completing and returning to the Association a prescribed form and such Alternate Authorised Representative shall meet all the requirements as stipulated in Article 8.1. and subject to the Board's approval.
- 8.4. With regard to the aforesaid stipulations in Articles 8.1. to 8.3., no person shall be appointed as Authorised Representative or Alternate Authorised Representative for more than one member concurrently.

- (b) 承诺遵守本会章程与/或议决案。
- 5.2. 准会员

任何有意申请为本会准会员者,必须符合下列所有条件:

- (a) 凡根据新加坡或其他国度相关法律注册或登记的任何企业、公司、商号、 代理商或任何其他形式的商业单位;以及
- (b) 承诺遵守本会章程与/或议决案。

8条 授权代表

- 8.1. 凡申请为普通或准会员者,须在申请时提名一位授权代表,该授权代表必须符合下列所有条件:
 - (a) 年龄至少 21 岁;
 - (b) 神智健全;
 - (c) 在该申请者公司内担任董事或高级职员,或本会所批准的其他人士:
 - (d) 未因违反任何国家的刑事法而被该国法院定罪且坐监超过两个星期者; 或被罚款超过两千元新币(或等值金额);以及
 - (e) 没有被判入穷籍者。
- 8.2. 若任何授权代表不符合上述第 8.1. 条文所列条件,有关会员有责任在发生这 类不符合条件事故后的 30 天之内通知本会,并且提名一位符合第 8.1. 条文 所有条件者取代之。
- 8.3. 任何会员若有意提名轮替授权代表,须填写并向本会递交指定的表格,而该轮替授权代表须符合第8.1.条文的所有条件,并须获得理事会的批准。
- 8.4. 关于第 8.1. 至第 8.3. 条文之规定,不能同时委任任何人担任超过一位会员的授权代表或轮替授权代表。
